**Subject: Recognition/ Approval of Rama Medical College Hospital & Research Centre, Kanpur, Uttar Pradesh for the award of MBBS degree granted by Dr. Bhim Rao Ambedkar University, Agra u/s 11(2) of the IMC Act, 1956.**

Sir,

I am directed to inform you that an assessment to assess the Under-Graduate teaching and training facilities available at Rama Medical College Hospital & Research Centre, Kanpur, Uttar Pradesh for the award of MBBS degree granted by Dr. Bhim Rao Ambedkar University, Agra was carried out by the Council Assessors on 25<sup>th</sup> & 26<sup>th</sup> April, 2013. The Board of Governors considered the assessment report (25<sup>th</sup> & 26<sup>th</sup> April, 2013) and the Board of Governors decided as under:

*"Approved for Recognition under Section 11(2) of IMC Act, 1956. However, prior permission of MCI is to be obtained for admission of batch 2014-15."*

In view of above, the Board of Governors decided to recommend that Rama Medical College, Hospital & Research Centre, Kanpur, Uttar Pradesh be approved for the award of MBBS Degree granted by Dr. Bhim Rao Ambedkar University, Agra with an annual intake of 100 (One Hundred only) students per year.

In view of above decision of Board of Governors, you are therefore requested to issue necessary notification at the earliest recognizing Rama Medical College Hospital & Research Centre, Kanpur, Uttar Pradesh for the award of MBBS Degree when granted on or after April, 2013 by Dr. Bhim Rao Ambedkar University, Agra.

It is also to inform that the Central Government vide letter No. U.12012/336/2006-ME (P-II) dated 29/09/2008 issued Letter of Permission for establishment of new medical college at Kanpur, Uttar Pradesh by Rama Educational Society, Kanpur, Uttar Pradesh with an annual intake of 100 students with prospective effect i.e. from the academic year 2008-09 u/s 10A of the IMC Act, 1956. A copy of letter dated 29/09/2008 along with the schedule of practical examination as submitted by the college authorities u/s 11(2) of the IMC Act, 1956 is enclosed herewith for your ready reference.

A copy of the assessment report is also enclosed herewith.
